Terms & Conditions of entry

4. Any prize is valued in Australian dollars unless expressly stated to the contrary.



  9. The Promoter accepts no responsibility for any late, lost, incomplete or incorrectly submitted entries. The Promoter is not liable for any consequences of user error including (without limitation) costs incurred. No correspondence will be entered into.
  10. The winner(s) will be notified on the day of the event prior to 6pm AEDT on 10 March 2023. The notification will include details on how to claim the prizes. The Promoter reserves the right to request for identity verification from the winner(s).
  11. The Promoter takes no responsibility where it is unable to contact prize winners who have not provided correct or complete contact details. If an entrant's contact details change during the promotional period, it is the entrant's responsibility to notify the Promoter.

16. Without limiting any of the foregoing, in no circumstances will an entrant or the Promoter have any liability to the other for any loss or damage suffered which is indirect or consequential in nature, including without limitation any loss of profit, loss of reputation, loss of goodwill, or loss of business opportunity.

17. The Promoter will not be liable for any delay, damage, or loss after the transfer of the Prizes to the winner.

18. The Promoter may in its absolute discretion not accept a particular entry, may disqualify an entry, or cancel the entire Promotion at any time without giving reasons and without liability to any entrants. Without limiting this the Promoter reserves the right to verify the validity of entries, prize claims and entrants and to disqualify any entrant who submits an entry or prize claim that is misleading or not in accordance with these Terms of entry or who manipulates or tampers with the entry process. In the event that a winner breaches these Terms of entry, the winner will forfeit the prize in whole and no substitute will be offered. Verification is at the discretion of the Promoter, whose decision is final. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

Where a prize is unavailable for any reason, the Promoter may substitute the prize for another item of equal or higher value. 21. The collection and disclosure of personal information provided in connection with this promotion will be handled in accordance with the Promoter's Privacy statement which adheres to the Privacy Act 1988 (cth) and Australian Privacy Principles.

22. The Promotion and these Terms of entry will be governed by the law of the State or Territory in which the Promoter ordinarily resides. Entrants accept the non-exclusive jurisdiction of courts and tribunals of that State or Territory in connection with disputes concerning the Promotion.
